#### WINTER / SNOW

# Winter Parking Ban

No person shall leave standing any vehicle upon any village street between the hours of 1 AM and 6 AM from **December 1 through April 1.** This will be <u>strictly enforced</u> when snow removal equipment is in operation.

#### **Snow Removal**

A reminder to property owners who have a sidewalk on your property - you are responsible for keeping your sidewalk clear of snow and ice. If the sidewalk is not clear, village employees will clear it and the cost will be billed to the property owner unless other arrangements were made with the Village Board.

# Mark Property Behind the Curb

If you have any shrubs, fences, etc. that are close to the curb or street, please mark them with posts and flags. Those operating snow removal equipment need to be aware that there is something buried under the snow. Manitowoc County will be doing our snow plowing this year.

#### General

- This is the time of the year for snow and ice problems on village streets; please cooperate with County and Village employees during this winter season.
- For safety reasons and per village ordinance, please **refrain from blowing or shoveling snow into the street**. The village may impose a penalty of not less than \$25 nor more than \$500, together with the costs of prosecution for each offense.
- The village and county are **not** responsible for damage to lawns, etc. caused by snow removal.
- Please keep garbage/recycling carts behind the curb while it is snowing. This allows the plows to keep the roads clear.

#### WATER SOFTENER INSPECTIONS

As a reminder, the **first inspection for all softeners** is **due May 1, 2024**. A Water Softener Inspection Form is available on the village's website: saintnazianz.org or at the Village Office. Please return your inspection documentation to the village once your softener is inspected.

#### **NOMINATION PAPERS**

Three Village Trustee terms will expire on April 16, 2024. Nomination papers are available for the Village Trustee Terms of Rich Galien, Scott Stebnitz, and John Thews. If you are interested, please call the Village Office for information. Papers must be filed with the Village Clerk-Treasurer on or before 5 PM on Tuesday, January 2, 2024.

#### **VILLAGE BOARD MEETINGS**

Regular meetings are held at **6:30 PM on the third Tuesday of each month** at the Village Hall. Special and committee meetings are called as needed. All official village notices and village meeting notices are posted 24 hours in advance at the Post Office, Village Shop, and the Village Hall.

#### **GARBAGE / RECYCLING**

Garbage & Recycling pickup is every **Thursday.** Have carts on the curb by 6AM. GFL would like you to place your carts at least **three** (3) **feet apart** at the curb. Call the office if you have questions. *See additional insert for more information*.

#### **DOG & CAT LICENSES**

Dog and cat licenses are due at this time for 2023. Certificates of current rabies vaccination must be presented when obtaining a dog or cat license.

**Fees:** \$5.00 for neutered male or spayed female; \$10.00 for unneutered male or unspayed female.

To license your pet, please either mail the rabies certificate, license fee, and self-addressed stamped envelope or bring the rabies certificate and license fee to the village office. (You can include license information with your tax payment; however, please pay with separate checks.)

There is a \$20.00 late fee per animal licensed after April 1, 2024.

# REPORTING STREETLIGHT PROBLEMS

#### **POLICE SPOTLIGHT**

Police Chief Al Bonfigt would like to remind drivers that the speed limit in the village is 25 MPH. Since the installation of the speed boards, speeds have reduced significantly. Help keep the village safe and drive responsibly! Please keep vehicles and homes locked when gone due to increased thefts of unlocked cars and homes. Also, when you are gone, leave a light on.
